Projects

A Victorian major infrastructure project

CoR Comply supported CoR compliance on one of Victoria's major infrastructure projects through two projects:

- A gap analysis of CYP's CoR compliance. Following the gap analysis, we rewrote the heavy vehicle/CoR procedures and developed a training needs analysis.
- In conjunction with Consolidated Plant Services, we developed a bespoke program of heavy vehicle inspections on Metro Tunnel worksites with the findings presented in a dashboard with risk ratings and an action plan for management.

The project was reported on to the Steering Committee for the project, with Executive General Managers for the three JV organisations; being tier one construction companies.
